



TALL SHIPS ABERDEEN 2025 CONCERTS SITE RULES

Entry into the Arena during ticketed concerts is subject to the following site rules:

- The Event Organisers reserve the right to refuse entry.
- Only people Aged 14+ (Under 16s to be accompanied by an adult aged over 21 years) will be admitted to the concert.
- A **Challenge 25** Policy is in operation at all bars. Anyone who appears under 25 will be asked to prove their age.
- We only accept a valid passport, foreign national ID cards, driving license or home office approved PASS hologram as identification and/or proof of age. We only accept originals, we do not accept photocopies.
- Any tickets that are damaged, defaced or have been purchased from an unauthorised agent will not permit the holder to be admitted to the venue.
- Patrons may be filmed/photographed whilst inside the venue.
- By entering the venue patrons' consent to their image, likeness or voice being captured and used as part of any recording of the event or any other purposes.
- Entry/exit searches and the right to search whilst inside the venue is a condition of entry. The entry search is mandatory, the others will be at the discretion of venue management. Bags should be limited to a maximum size of A3.
- The Event Organisers operate a zero-tolerance policy to drugs. Anyone found with illegal drugs will be ejected from the venue and reported to the police. Anyone found to be asking for drugs or offering drugs in or around the venue will also be ejected and banned from the venue and reported to Police. Anyone found to be in possession of an offensive weapon will be ejected and banned from the venue and the police will be called.
- The carriage and operation of drones and Unmanned Aerial Vehicles (or any such aircraft) is prohibited.
- The Event Organisers reserve the right to inspect any bag and/or articles of clothing for the following prohibited items:
 - Alcoholic Beverages;
 - Illegal substances including controlled, dangerous or illicit drugs;
 - Opened Drink Containers;
 - Cans/glass;
 - Unauthorised temporary signage and promotional products;
 - Flags/banners;
 - Fireworks/flares/laser lights/smoke generators;
 - Firearms, explosives, chemical, radioactive or biological substances;
 - Chairs/stools;
 - Rollerblades/skates, skateboards, scooters or bicycles;
 - Animals (other than guide/assistance dogs);
 - Professional cameras, audio recording equipment, video cameras or tripods; and/or
 - Any other item that in the opinion of management could cause harm or public nuisance.
- Patrons may be liable for prosecution, fined or ejected from the venue if they:
 - have entered the venue and/or the venue without prior authorisation;
 - are deemed by management to be displaying disorderly, offensive or unlawful behaviour;
 - use foul or abusive language, or make racial or threatening remarks or gestures; or
 - fail to comply with any of these Conditions of Entry or requests from the Venue or Event staff or their representatives.
- No ticket refund will be paid to patrons ejected from the venue. If removed, it is an offence to re-enter or attempt to re-enter the venue.
