

1. The Promoter

3. How to Enter

- 3.1. The competition will run from 12:01am GMT on 14 April 2025 to 11:59 GMT on 20 July 2025 (the "Closing Date") inclusive.
- 3.2. All competition entries must be received by Tall Ships Aberdeen no later than 11:59 GMT on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.
